
Sprint Communications Company L.P. ("Sprint") received a copy of a letter filed in the above docket on October 31, 2007 by Whidbey Telephone Company ("Whidbey"). Whidbey's letter is not properly filed pursuant to Order 01. Paragraph 5 of the Order only allows for objections to the dates reported in Paragraph 3. Whidbey's letter does not dispute the correctness of those dates so Whidbey's letter should be disregarded as it does not comply with Order 01.

Furthermore Whidbey's letter incorrectly states that the Petition "was not delivered or served on Whidbey until October 25, 2007." As evidenced by the Certificate of Service filed in this docket Whidbey was served on October 17, 2007, the same day the Petition was filed. The recipient of service was Robert S. Snyder, the person designated by Whidbey as its point of contact and negotiating representative for all matters associated with Sprint's interconnection request. 
