1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: Feb 1, 2008.
2. The proposed changes will expire on: June 30, 2008.
3. The temporary .47% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of September, October and November 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of March, April, and May 2008.

Customers who are billed quarterly for services – one month in arrears, current and one month in advance:

April 2008 /	March, April and May 2008
May 2008 /	April, May, and June 2008
