3. The temporary 1.46% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June, July & August 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November and December 2008.
