- On November 3, 2009, Christopher R. Hood, d/b/a A2B Moving, (Applicant), filed an application with the Washington Utilities and Transportation Commission (Commission) for permanent household goods carrier authority in the state of Washington under RCW 81.80 and WAC 480-15, rules relating to motor carriers of household goods.

Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.
