- On November 9, 2009, Columbia Basin Movers & Storage, LLC, (Applicant), filed an application with the Washington Utilities and Transportation Commission (Commission) for permanent household goods carrier authority in the state of Washington under RCW 81.80 and WAC 480-15, rules relating to motor carriers of household goods.
