## Monte,

UTC already granted an extension back in September 2010, extending the deadline to June 15, 2011. Another extension is not an option because projects associated with this grant must be completed by June 30, 2011, which is the end of the state biennium. At this point, it doesn't seem likely that the fence will be constructed by June 15, 2011, so I recommend that the school district withdraw the application, otherwise it will be dismissed around June 15<sup>th</sup>. It's unfortunate that the fence was not constructed because of the safety issues present near the tracks and the availability of funding provided by UTC.

At this point, UTC does not know if our grant program will be funded in the 2011-2013 biennium. If it is, the school district could reapply for funding but UTC would need assurance from the school district that they would follow through this time.
