Re: Rulemaking to Consider Adoption of Rules to Implement SSB 5362, Chapter 480-30 WAC, Relating to Charter Bus Companies, Docket TE-151080

#### TO ALL INTERESTED PERSONS:

This letter informs you of the progress made in this rulemaking concerning the possible adoption of revisions to chapter 480-30 WAC relating to charter bus companies. This rulemaking is designed to implement SSB 5362, passed and signed into law in the 2015 legislative session. This letter also provides notice of an opportunity to file written comments by Monday, November 23, 2015, on the proposed rules and to participate in the formal rule adoption hearing scheduled for Tuesday, December 15, 2015, at 9:30 a.m.

On October 21, 2015, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The proposed rules would affect chapter 480-30 WAC, relating to charter bus companies, and is limited to the provisions of SSB 5362, including:

- Defines "party bus"
- Removes the current exemption for buses operating within a single city
- Regulates alcohol served or consumed on party buses
- Prohibits smoking on charter buses
- Changes the due date for charter bus regulatory fees
- Defines charter party services to include certain advertising activities
- Allows a penalty up to \$5,000 for operating without a permit
