MR. BARTLETT: Present.

JUDGE PEARSON: Okay. Thank you,  
Mr. Bartlett.

Docket TV-151658, James Mwangi.

MR. MWANGI: Present.

JUDGE PEARSON: Okay. Thank you,  
Mr. Mwangi. Am I pronouncing your name correctly?

MR. MWANGI: Absolutely.

JUDGE PEARSON: Okay.

And Docket TV-151680, Daniel Zeufeldt.

Okay. Hearing nothing.

There are three companies who have not entered an appearance today. Those companies are subject to being held in default and having an order entered against them without a chance to address the Commission, and I will take those cases up later this morning.

Ms. Banks, have you had communication with any of the three companies that did not enter an

 2 MS. BANKS: Yes. I heard from -- yes, I  
 3 heard from --  
 4 JUDGE PEARSON: Is the red light on?  
 5 MS. BANKS: Yes.  
 6 JUDGE PEARSON: There you go.  
 7 MS. BANKS: Yes. I've heard from  
 8 Ms. Bergman this morning, and she will be running late  
 9 because of traffic.  
 10 JUDGE PEARSON: Okay. Did she indicate an  
 11 approximate arrival time?  
 12 MS. BANKS: She said approximately 10:00.  
 13 JUDGE PEARSON: Okay. Thank you.  
 14 So you are all here today because the  
 15 Commission filed a complaint alleging that your  
 16 companies are performing or advertising to perform work  
 17 as household goods carriers without the required permit.  
 18 And the purpose of today's proceeding is to  
 19 formally explain what your choices are and then hear  
 20 from each of you regarding which option you wish to  
 21 pursue. So you can chose from one of two options today  
 22 on behalf of your company.  
 23 The first is to cease and desist providing,  
 24 offering to provide, or advertising to provide  
 25 unpermitted household goods services.

1 So if you choose this option, you'll need to  
 2 demonstrate what you've done to shut down your business  
 3 either completely or partially to avoid further  
 4 enforcement action by the Commission. So I'm going to  
 5 want to see some kind of proof that you're no longer  
 6 performing the services; for example, if you have proof  
 7 that you've taken down or changed your website or your  
 8 online advertisements for your business.  
 9 The second option is to ask for a formal  
 10 classification hearing to show why you don't believe you  
 11 need a permit. So if you choose that option, you're  
 12 contesting the allegations in the complaint and claiming  
 13 not to be conducting household goods moving services.  
 14 So for that option, we will schedule a  
 15 formal hearing for a date in the near future with a  
 16 deadline two to three weeks from now for both your  
 17 company and Commission staff to declare all witnesses  
 18 and file any exhibits.  
 19 Each of you has a right to be heard by the  
 20 Commission, so I will call you up individually to do  
 21 that. And Commission staff also has a right to be  
 22 heard, and Ms. Megan Banks will be representing the  
 23 Commission this morning. If you've not already met  
 24 Ms. Banks, she's seated to the right over here, and  
 25 she's a Commission Compliance Investigator.

1 So in a few minutes, I'll call each of you  
 2 forward to make your choice on how you wish to proceed.  
 3 And at that time, I will swear you in so that anything  
 4 you say will be under oath and considered sworn  
 5 testimony.  
 6 Once you're sworn in, I'll ask you if you  
 7 understand your options for today's proceeding and then  
 8 ask you to state what your choice is going to be. And  
 9 if there's anything else that you want to explain to me,  
 10 you can do so at that time.  
 11 So in each of the complaints, Commission  
 12 staff alleged you're providing household goods moving  
 13 services without a permit, and they are also seeking to  
 14 have a penalty imposed. Staff will be making a penalty  
 15 recommendation as part of any agreed order that you  
 16 might reach today. Ms. Banks will be explaining that  
 17 recommendation, but the Commission will be making the  
 18 final decision about the amount of the penalty that will  
 19 be imposed.  
 20 If you choose to testify about how you're  
 21 getting out of the household goods business, I will  
 22 allow you to make a statement explaining how you plan to  
 23 do that, and depending on what proof you can provide,  
 24 you should be able to reach an agreed order resolving  
 25 the matter with Ms. Banks, and you can speak to her

1 about that during the recess.  
 2 And finally, if you choose to contest the  
 3 allegations in the complaint, like I said, we will  
 4 schedule another hearing for the Commission to present  
 5 evidence to prove its case. And if we're going to set a  
 6 hearing, it would be helpful if you know your schedule  
 7 for the next month or so when we review our calendars.  
 8 So after I hear from each of the three of  
 9 you, we'll take a break for about an hour which will  
 10 provide Commission staff time to meet with each of you  
 11 and prepare a final disposition for your cases.  
 12 For most of you, I believe Ms. Banks will be  
 13 presenting agreed orders, and an agreed order will  
 14 essentially say that you agree that you are operating  
 15 without a permit, that you advertised without a permit,  
 16 and that you agree to stop operating until you get a  
 17 permit if you decide to apply for one.  
 18 Once you're satisfied that you understand  
 19 all the terms of the order, you and Ms. Banks will both  
 20 sign it, and it will also most likely include an  
 21 agreement about the amount of the penalty, which -- to  
 22 be imposed. But if not, you can make your case about  
 23 why the penalty should be different than what Staff is  
 24 recommending.  
 25 Ms. Banks, do you want to make any general

1 statements on behalf of Commission staff before I call  
 2 the cases individually?  
 3 MS. BANKS: Not at this time.  
 4 JUDGE PEARSON: Okay.  
 5 Why don't we go ahead and swear you in so

 10 and then press the button. And when the red light comes  
 11 on, that means it's working.

 14 So how do you wish to proceed this morning?  
 15 MR. PETRIE: The first option. It's already  
 16 shut down. I mean, I'm the son of the owner, and my dad  
 17 is -- he couldn't be present right now, but he told me

 19 JUDGE PEARSON: So you're representing the  
 20 company today --  
 21 MR. PETRIE: Yeah, I guess.  
 22 JUDGE PEARSON: -- as the owner's son?  
 23 MR. PETRIE: But it's been closed. We never  
 24 even started. I got this packet with my name on it.  
 25 I'm just here to clear my name or whatever you guys want

1 to do, penalize [sic] him, that's fine or whatever,  
 2 but I don't really have an hour to spare neither.  
 3 JUDGE PEARSON: Okay. Did you bring any  
 4 documentation with you?  
 5 MR. PETRIE: I can call a friend that sold  
 6 the truck and maybe send documentation through -- via  
 7 text or something. But he did write a letter to the  
 8 business license in Tacoma and let them know that it is  
 9 no longer up and running or whatever, so he doesn't get  
 10 taxed. Because recently he's been incarcerated so he  
 11 doesn't want to be taxed while he's gone.  
 12 JUDGE PEARSON: Is he presently  
 13 incarcerated?  
 14 MR. PETRIE: Yes.  
 15 JUDGE PEARSON: Okay. So he couldn't be  
 16 here today?  
 17 MR. PETRIE: That's exactly the reason. But  
 18 he never got it up and running, never did any moves. He  
 19 bought a truck, figured out all this, sold the truck,  
 20 and like maybe three weeks later a packet comes to the  
 21 door with my name on it. I just want to clear my name  
 22 from it because I was never part of it.  
 23 JUDGE PEARSON: Okay.  
 24 MR. PETRIE: I got my own stuff going on.  
 25 JUDGE PEARSON: So you can speak with

1 Ms. Banks about that during the recess.  
 2 MR. PETRIE: Yeah. I had called and talked  
 3 to her, but she said try to be present.  
 4 JUDGE PEARSON: Yes. It's definitely

1 CHARLES BARTLETT, witness herein, having been  
 2 first duly sworn on oath,  
 3 was examined and testified  
 4 as follows:  
 5  
 6 JUDGE PEARSON: Okay. Thank you,  
 7 Mr. Bartlett.  
 8 How do you wish to proceed this morning?  
 9 MR. BARTLETT: Basically I'm just --  
 10 JUDGE PEARSON: If you can just take a seat  
 11 and speak into the microphone. I'm sorry.  
 12 MR. BARTLETT: Okay. Basically I've done --  
 13 I took off all my signs and everything and put my truck  
 14 up for consignment over here at M&M Motors. They're  
 15 selling it. And besides, the insurance is kind of high,  
 16 you know.  
 17 JUDGE PEARSON: So you wish --  
 18 MR. BARTLETT: I wasn't making no money. I  
 19 wasn't making the kind of money that I felt I needed to  
 20 be making anyway, and I thought -- I mean, I had my  
 21 insurance anyway -- my certificate and my insurance  
 22 anyway until the 16th of September -- I mean until the  
 23 29th of September, so -- but I didn't know the whole  
 24 procedures and all that good stuff for -- for -- you  
 25 gotta have a permit and you gotta pay for insurance.

1 And it's, like, once -- you know, I think you got --  
 2 once you pay for the -- pay for the permit, then you  
 3 gotta pay this high insurance.  
 4 I mean, I had a 24-footer. To me, \$379 a  
 5 month for insurance, to be honest with you, to tell the  
 6 truth, is too high for me. And so, therefore, that was  
 7 one of the reasons why when you guys did what you all  
 8 did, set me up and did what you did, I said, end of an  
 9 era, you know.  
 10 I gave it a shot, and I was spending more  
 11 money than I was making, you know. So if I was getting  
 12 into the business -- if I would get back into the  
 13 business, I would have to have, like, maybe a 15-footer.  
 14 Hopefully the insurance would be a little cheaper, you  
 15 know.  
 16 But you know, I need a job that I have  
 17 benefits. I mean, I wasn't getting no benefits. You  
 18 gotta pay this and pay that, it's a lot of money, to be  
 19 honest with you. You say tell the truth. So I'm done.  
 20 JUDGE PEARSON: Okay. And you are the owner  
 21 of Affordable Haulers & Movers?  
 22 MR. BARTLETT: Yes, ma'am.  
 23 JUDGE PEARSON: Okay. So you wish to --  
 24 MR. BARTLETT: Decline.  
 25 JUDGE PEARSON: Cease and desist?

1 MR. BARTLETT: I would ask to because it's  
 2 just too much money, and I'm gonna -- I'm gonna just get  
 3 a regular job and be a normal individual.  
 4 JUDGE PEARSON: Okay.  
 5 MR. BARTLETT: I only got ten years left.  
 6 I'm in my 50s.  
 7 JUDGE PEARSON: Okay. Just stay seated for  
 8 a moment.  
 9 Ms. Banks, do you wish to make a  
 10 recommendation regarding the cease and desist order?  
 11 MS. BANKS: The Staff would agree with a  
 12 cease and desist order.  
 13 JUDGE PEARSON: Okay. Great. Thank you.  
 14 Mr. Bartlett, you can go ahead and take a  
 15 seat.  
 16 MR. BARTLETT: Thank you.  
 17 JUDGE PEARSON: Okay.  
 18 Docket TV-151658, James Mwangi.  
 19 All right. Mr. Mwangi, if you could raise  
 20 your right hand.  
 21  
 22 JAMES MWANGI, witness herein, having been  
 23 first duly sworn on oath,  
 24 was examined and testified  
 25 as follows:

1 JUDGE PEARSON: Okay. Thank you. You can  
 2 go ahead and have a seat.  
 3 All right. And just to clarify, you are the  
 4 owner of Safe to Go Movers; is that correct?  
 5 MR. MWANGI: I am.  
 6 JUDGE PEARSON: Okay. And how do you want  
 7 to proceed this morning?  
 8 MR. MWANGI: Your Honor, I would like to go  
 9 with the first option.  
 10 JUDGE PEARSON: Okay. You want to do the  
 11 cease and desist?  
 12 MR. MWANGI: Um-hmm.  
 13 JUDGE PEARSON: Okay.  
 14 MR. MWANGI: However, I would like to  
 15 mention, I have called Ms. Banks a few times regarding  
 16 this option that I chose, and I've been working  
 17 diligently toward the attainment of licensing.  
 18 Now, as luck would have it, I just a  
 19 couple -- last week the license came. And I actually  
 20 called Ms. Banks a couple days ago, I left her an  
 21 e-mail -- I mean I left a voicemail, and we do have the  
 22 license now.  
 23 And from the time I got the packet summoning  
 24 me to come here to the Court, I have desisted from  
 25 posting, from -- and also I brought down the website.

1 And I do have all the documentation to prove that that  
 2 has been -- the website has been brought down, and I've  
 3 desisted from posting on Craigslist.  
 4 JUDGE PEARSON: Okay. Great. The  
 5 Commission's goal is always compliance, so I'm happy to  
 6 hear that you've applied for a permit, and signing the  
 7 cease and desist order won't affect the status of your  
 8 permit application. It's just saying that, in the event  
 9 that you don't have a permit, you will not operate until  
 10 your permit is back in active status.  
 11 MR. MWANGI: Okay.  
 12 JUDGE PEARSON: Okay?  
 13 MR. MWANGI: Okay. So it's now back and  
 14 active, so -- the temporary one. But I mean, I wanted  
 15 to wait until I appeared in court today before I can  
 16 assume the procedure of posting and advertising.  
 17 JUDGE PEARSON: Okay. Great.  
 18 And Ms. Banks, do you have a recommendation  
 19 with regard to the cease and desist order?  
 20 MS. BANKS: Staff would agree with the cease  
 21 and desist until the permit was received.  
 22 JUDGE PEARSON: Okay. Thank you.  
 23 All right. Mr. Mwangi, you may step down.  
 24 Thank you.  
 25 MR. MWANGI: Thank you.

1 JUDGE PEARSON: And can you please identify  
 2 yourself?  
 3 MR. MARTIN: Edward Martin.  
 4 JUDGE PEARSON: So you're Edward Martin.  
 5 Okay. Great.  
 6 So that is Docket TV-151654 for Martin  
 7 Movers. If you could please come forward to the front,  
 8 I'll swear you in and then I will brief you on what's  
 9 happening this morning.  
 10 MR. MARTIN: Up here?  
 11 JUDGE PEARSON: You can come to this seat  
 12 right here. Why don't you just go ahead and raise your  
 13 right hand.  
 14  
 15 EDWARD MARTIN, witness herein, having been  
 16 first duly sworn on oath,  
 17 was examined and testified  
 18 as follows:  
 19  
 20 JUDGE PEARSON: Okay. Thank you. You can  
 21 have a seat.  
 22 MR. MARTIN: All right.  
 23 JUDGE PEARSON: I'm sorry. Up here at the  
 24 table, you can have a seat.  
 25 So Mr. Martin, you are the owner of Martin

1 Movers; is that correct?  
 2 MR. MARTIN: Yes.  
 3 JUDGE PEARSON: Okay. So you're here today  
 4 because the Commission filed a complaint against you  
 5 alleging that you are providing, offering to provide or  
 6 advertising for unpermitted household goods moving  
 7 services.  
 8 And what we're doing here today is asking  
 9 each of you and your companies to make a decision about  
 10 whether you agree to cease and desist from operating  
 11 without a permit, which doesn't mean that you can't get  
 12 a permit, it just means that you're agreeing that you  
 13 will not operate until such time that the Commission  
 14 grants you a permit.  
 15 Have you had an opportunity to speak with  
 16 Ms. Banks in advance of today's hearing?  
 17 MR. MARTIN: Yes.  
 18 JUDGE PEARSON: Okay. So the other option  
 19 that would be available to you is if you wanted a  
 20 classification hearing to contest the allegations  
 21 against you, where you would be arguing that you're not  
 22 providing household goods moves, and Staff would have an  
 23 opportunity to prove that, in fact, that is what you're  
 24 doing.  
 25 So do you know which option you want to go

1 with today?  
 2 MR. MARTIN: Well, I can cease until I get  
 3 the permit.  
 4 JUDGE PEARSON: Okay. So you want to do the  
 5 cease and desist then?  
 6 MR. MARTIN: Yeah.  
 7 JUDGE PEARSON: Okay.  
 8 So there's also going to be -- Staff has  
 9 recommended a \$5,000 penalty against each company, but  
 10 when we take a recess, you'll have the opportunity to  
 11 meet with Staff and discuss the possibility of modifying  
 12 that penalty amount, most likely with a portion of it  
 13 suspended for two years.  
 14 MR. MARTIN: A portion? Well, this is my  
 15 only issue. I never got a notice or e-mail, any  
 16 information that I was out of compliance.  
 17 JUDGE PEARSON: Okay.  
 18 MR. MARTIN: So I never received the notice,  
 19 so -- all I received was this right here.  
 20 JUDGE PEARSON: Okay. Well, you'll have an  
 21 opportunity to discuss that with Ms. Banks at the  
 22 break --  
 23 MR. MARTIN: Okay.  
 24 JUDGE PEARSON: -- in determining what her  
 25 penalty recommendation will be.

1 MR. MARTIN: Okay. So by me saying cease  
 2 and desist, that puts me in a position to where I have  
 3 to receive a penalty; is that what that is?  
 4 JUDGE PEARSON: Regardless of what position  
 5 you took, the Commission would most likely assess a  
 6 penalty today unless you asked for a classification  
 7 hearing and claim not to be providing household goods  
 8 moving services, in which case you would have to prove  
 9 that you weren't providing household goods moving  
 10 services.  
 11 But these complaints were brought forward,  
 12 and the Commission has already found probable cause.  
 13 And you've seen Ms. Banks' declarations that include  
 14 offers that she received and proof of advertisements.  
 15 So it would be difficult for anyone who was brought here  
 16 today to prove that they were not, in fact, offering  
 17 household goods moves unless it was some case of  
 18 mistaken identity or identity theft.  
 19 MR. MARTIN: Well, I was providing help with  
 20 unload and load. That's what I was providing.  
 21 JUDGE PEARSON: Okay. Well, you can discuss  
 22 that with Ms. Banks at the break and discuss what  
 23 evidence that she's brought against you. She's the best  
 24 person for you to discuss what the penalty  
 25 recommendation should be at this point in time.

1 MR. MARTIN: Okay. So if I go the other  
 2 route, am I saying that I want to go to court hearing or  
 3 trial or something?  
 4 JUDGE PEARSON: You'd have another hearing  
 5 here where you would be contesting that you ever offered  
 6 to provide a household goods move or offered to a  
 7 provide a truck in connection with a household goods  
 8 move, and contesting that any of the documentation that  
 9 has been put forth by Staff is real, basically. You'd  
 10 have to prove that it's -- that it's not true.  
 11 MR. MARTIN: Okay. Well, like I said, the  
 12 issue I have is I didn't know I was out of compliance.  
 13 That's my -- I mean, I never got an e-mail, a notice,  
 14 hey, you're out of compliance, you can't do this no  
 15 more. I never got a notice like that.  
 16 So I'm just wondering, how can I get  
 17 punished for something that I never even got an e-mail  
 18 or a text or anything saying, hey, you're out of  
 19 compliance, not even a phone call.  
 20 JUDGE PEARSON: So the Commission does send  
 21 compliance letters as a courtesy to people who --  
 22 MR. MARTIN: Right, I never got none of --  
 23 JUDGE PEARSON: -- are conducting moves  
 24 illegally; however, it is your responsibility to know  
 25 the laws of Washington state if you're going to open

1 your own business, and to do your due diligence to  
 2 determine what types of licenses that you would need to  
 3 have to perform household goods moving services.  
 4 So the Commission's not under any obligation  
 5 to contact you. The burden is on you to figure out  
 6 which licenses and permits you need to conduct your  
 7 business. But that's certainly something you can  
 8 address with Ms. Banks at the break.  
 9 MR. MARTIN: Okay. Well, if I change my  
 10 mind, can I do that here, or do I have to --  
 11 JUDGE PEARSON: You can change your mind  
 12 after talking with Ms. Banks, yes.  
 13 MR. MARTIN: Okay.  
 14 JUDGE PEARSON: You're free to do that.  
 15 Ms. Banks, do you have a recommendation with  
 16 respect to the cease and desist?  
 17 MS. BANKS: Staff would agree with a cease  
 18 and desist.  
 19 JUDGE PEARSON: Okay. Great. Thank you.  
 20 All right. You may have a seat.  
 21 Okay. So we're still waiting for  
 22 Ms. Bergman. I think at this point, it's about 9:25  
 23 a.m., we can take a recess and you can begin your  
 24 discussions with the movers who are present here today.  
 25 And when Ms. Bergman -- or when Ms. Bergman

1 arrives, if that is prior to the time when you have  
 2 completed your conversations with these gentlemen, you  
 3 can give me a call and I can come back into the hearing  
 4 room and brief her on what her choices are and then we

 25 Then at approximately 9:26 a.m., we are at

 2 get me or give me a call when I need to come back.  
 3 (A break was taken from  
 4 9:26 a.m. to 11:04 a.m.)  
 5 JUDGE PEARSON: Okay. Good morning. We are

 7 a recess.  
 8 Ms. Banks, do you have any updates for me

 17 we will go ahead and proceed.  
 18 Once we take up with each of the companies  
 19 here, if she's still not present at that point in time,

 22 And is there any particular order in which  
 23 you'd like me to call the companies?  
 24 MS. BANKS: Yes. Could you please call  
 25 Mr. Martin of Martin Movers, TV-151654, first?

 3 MS. BANKS: And then if we could call

 13 Is the microphone on?  
 14 MR. MARTIN: Yeah.  
 15 JUDGE PEARSON: Okay.

 18 MS. BANKS: We were unable to come to an  
 19 agreement with Mr. Martin. Staff would recommend the  
 20 \$5,000 penalty with \$4,500 suspended and \$500 due  
 21 immediately.  
 22 JUDGE PEARSON: Okay.  
 23 And Mr. Martin, what's your response to  
 24 Staff's recommendation?  
 25 MR. MARTIN: See, I just made a phone call,

 22 my income doesn't have me where I can give anything  
 23 today. I have bills just like everybody else. And  
 24 today I wasn't expecting to pay a \$500 bill or give \$10,  
 25 \$5 or anything.

1 JUDGE PEARSON: I understand that. My  
 2 preference is that we enter an agreed order today as  
 3 opposed to me entering an order following this hearing,  
 4 in which case I would likely accept Staff's  
 5 recommendation of imposing the \$500 penalty due and  
 6 payable immediately.  
 7 So if you are able to make any sort of  
 8 payment today and you want a second opportunity to talk  
 9 to Ms. Banks about that, I will give you that

 18 JUDGE PEARSON: Next I'll call Docket  
 19 TV-151657, Mr. Bartlett, if you could come up to the  
 20 front and have a seat.  
 21 Okay. And Ms. Banks, what was the  
 22 disposition of Mr. Bartlett's case?  
 23 MS. BANKS: We also were not able to come to  
 24 an agreement with Mr. Bartlett.  
 25 Staff would recommend in this case a \$5,000

1 penalty with \$4,000 suspended and \$1,000 due.  
 2 The reason for the increased penalty is  
 3 because Mr. Bartlett has had a permit from 2012 through  
 4 2014. He lost it briefly for insurance. He received it  
 5 again in two thousand -- October 2014, and then he  
 6 requested that his permit be cancelled and he -- it was  
 7 cancelled for insurance in March 2015.  
 8 Because Mr. Bartlett is aware of the rules  
 9 and has been in compliance with the rules previously and  
 10 has chosen since March 2015 to be out of compliance,  
 11 Staff recommends a higher penalty of \$1,000 be imposed.  
 12 JUDGE PEARSON: All right.  
 13 And Mr. Bartlett, what's your response to  
 14 Staff's recommendation?  
 15 MR. BARTLETT: I mean, that means the price  
 16 is, I guess -- I mean, whatever, the situation what she  
 17 said, I mean, I guess that's the way she -- you know,  
 18 she looked at it.  
 19 But for me, like I said, I don't have a job,  
 20 and I don't have no way of paying it. I mean, where I'm  
 21 at, I'm basically -- I'm basically homeless is what I  
 22 tried to tell her. I'm in a situation where it's, like,  
 23 housing, and I'm just trying to get a job and do the  
 24 right thing because, hey, I can't afford it. I don't  
 25 have anything, ma'am. To be honest with you, I'm

1 basically homeless.  
 2 JUDGE PEARSON: Okay. I understand that.  
 3 MR. BARTLETT: I don't have it.  
 4 JUDGE PEARSON: Like I said --  
 5 MR. BARTLETT: I don't have anything.  
 6 JUDGE PEARSON: Like I said to Mr. Martin --  
 7 you need to be quiet while I'm talking.  
 8 Like I said to Mr. Martin, if you were able  
 9 to make a payment today, then we would be able to set up  
 10 a payment arrangement with you. But if you're not, then  
 11 I'm going to go ahead and accept Staff's recommendation  
 12 and impose \$1,000 of a penalty and suspend the other  
 13 \$4,000 for a two-year period contingent on you  
 14 refraining from providing or advertising to provide  
 15 household goods moving services.  
 16 MR. BARTLETT: Can I say something?  
 17 JUDGE PEARSON: Sure.  
 18 MR. BARTLETT: Would I be able to work out  
 19 getting the -- getting the permit within 30 days and --  
 20 because it will be a better deal than -- and then it  
 21 would be a better deal than the \$1,000 of the payment.  
 22 JUDGE PEARSON: That is not an offer that  
 23 was on the table today. We only offer two choices at  
 24 these proceedings, which is either agree to the cease  
 25 and desist and to pay a portion of the penalty, or to

1 ask for a formal classification hearing.  
 2 So -- so no, I can't issue an order with a  
 3 30-day condition on it like that.  
 4 MR. BARTLETT: Or --  
 5 JUDGE PEARSON: Are you able to make any

 25 for the permit. I said I would be able to get it within

 25 attended twice, so you have been well-advised.

 25 We will issue an order, a prehearing conference order

 12 understanding was that if it didn't get here on the 24th  
 13 that you guys couldn't really verify the actual date, so  
 14 they counted it as being late.  
 15 So I filled out an application and sent it  
 16 in with a certain amount, and I remember getting a call  
 17 from Gina that I didn't fill out the proper amount  
 18 because I applied for a partial, not a full, and so I  
 19 didn't know I needed to apply for full.  
 20 And so at that point, that's what I  
 21 remember, and then everything kind of changed for me,  
 22 so -- my daughter was murdered and --  
 23 JUDGE PEARSON: I'm sorry to hear that.  
 24 MS. BERGMAN: -- my family tried to take  
 25 over the company to help me through this, and no one
