Transportation or solid waste requiring special equipment or precautions in handling or disposal will be subject to time rates named in Item 160, or to other special rates contained in this tariff.

Those costs shall be passed through to the customer without markup. The company must maintain records of time spent to accomplish the special testing and/or analysis, and may bill the customer for that time under provisions of Item 160 (Time Rates).
