SUNCADIA WATER CUSTOMER INFORMATION

Dear customers,

In October 2019, NW Natural Water, a wholly-owned subsidiary of NW Natural Holdings, entered into an agreement to acquire the water utility of Suncadia Resort, Suncadia Water Company. This transfer is contingent upon approval by the Washington Utilities and Transportation Commission (WUTC).

After the sale is approved, the utility will continue to be operated locally with the oversight of Suncadia Water's team made up of professionals from the Cle Elum area. NW Natural Water and Suncadia Water expect that the transition will be seamless to customers. Suncadia Water's current rates and charges will not change as a result of this transaction and NW Natural Water will be required to notify all affected customers of any future rate increases.

About NW Natural Water

NW Natural Water currently provides water distribution service to communities throughout the Pacific Northwest. Since 2018, NW Natural Water has acquired a number of water distribution systems and has additional acquisitions pending. Upon closing all outstanding transactions, cumulatively, NW Natural Water will serve approximately 53,000 people through about 21,000 connections in the Pacific Northwest. NW Natural Water is a subsidiary of NW Natural Holdings (NYSE:NWN). NW Natural Holdings is headquartered in Portland, Oregon, and through its subsidiaries has been doing business for 160 years in the Pacific Northwest.
