Following conversations with Commission Staff, the attached revised Petition reflects changes requested by Staff.

PSE requests confidential treatment for parts of pages 3 and 4 of the petition under RCW 80.04.095 and in accordance with WAC 480-07-160. The information labeled as confidential includes third quarter 2020 confidential financial information related to liquidated damages, which could expose PSE to competitive injury if disclosure is unrestricted prior to the information becoming public. Actual amounts for the third quarter 2020 require confidential treatment until PSE's financial results are published in its Form 10Q which is expected to be November 4, 2020, at which time the confidential designation for third quarter amounts is no longer necessary. Therefore, PSE requests confidential treatment on the basis that the information labeled "Shaded Information is Designated as Confidential per WAC 480-07-160" contains "confidential financial information," as provided in in RCW 80.04.095 in accordance with WAC 480-07-160(2)(c).
