RATE INCREASE NOTICE FOR MASON COUNTY COMMERCIAL CONTAINER AND CARTS

Dear Customer:

January 26, 2021

Mason County Garbage Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC April 1, 2013. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, and truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates below will become effective March 1, 2021.

The Commission has the authority to set final rates that may be either lower or higher from the company's request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 9:30 a.m. on February 25, 2021. The UTC building is closed to the public until further notice. This open meeting will be conducted remotely.
