ORDER GRANTING APPLICATION; TRANSFERING CERTIFICATE G000173

BACKGROUND

- On October 18, 2021, Sanitary Disposal Inc (Sanitary Disposal), and Waste Connections of Oregon, Inc d/b/a Sanitary Disposal (Waste Connections of Oregon) filed a joint application and tariff adoption notice in Docket TG-210796 with the Washington Utilities and Transportation Commission (Commission) for authority to transfer all rights under certificate of public convenience and necessity G000173 from Sanitary Disposal to Waste Connections of Oregon.
- 2 Certificate G000173 is held by Sanitary Disposal and authorizes solid waste collection as described in the certificate.
- ³ The application appeared on the October 21, 2021, application docket. Interested parties were notified of the application to give them an opportunity to express their views. The application was not protested.

DISCUSSION AND DECISION

- 4 The Commission, having considered the application and being fully advised, finds that Waste Connections of Oregon is fit, willing and able to furnish the transfer of rights under certificate G000173, and that the transfer of rights under that certificate to Waste Connections of Oregon will not be detrimental to the public interest.
- 5 Furthermore, the Commission, having considered the application and being fully advised, finds that Waste Connections of Oregon is fit, willing, and able to furnish the transferred service and that the transferred service continues to be necessary and a convenience to the public.

ORDER

THE COMMISSION ORDERS:

- 6 (1) The application filed in this docket to transfer the rights in the State of Washington from Sanitary Disposal, Inc to Waste Connections of Oregon, Inc d/b/a Sanitary Disposal is granted upon the applicant complying with RCW 81.77 and WAC 480-70, relating to solid waste collection companies.
- 7 (2) Certificate G000173 is (re)issued to Waste Connections of Oregon, Inc d/b/a Sanitary Disposal as described in attached Appendix A.
- 8 (3) The tariff adopted in connection with this application will become effective at 12:01 a.m. on the day following the service date of this Order.
- 9 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(6)(c).
