Pursuant to RCW 80.28.060, WAC 480-80-101 and -105, and WAC 480-07-880, enclosed is a copy of the following revised tariff sheets in compliance with the Commission’s Order 01.

Puget Sound Energy (“PSE” or the “Company”) accepts all conditions of approval set by the Order.

On September 30, 2024, PSE filed with the Commission revisions to its Tariff WN U-60, Tariff G, Electric Service, which was assigned Docket UE-240729. On December 19, 2024, the Commission entered Order 01 (‘Order’) which directed the Company to file revised tariff sheets by December 23, 2024 with an effective date of January 1, 2025 and indicating that the increased rates in this docket are subject to refund.

The purpose of this compliance filing is to comply with Order 01 in Docket UE-240729, which requires PSE to make a compliance filing adding tariff language to Schedule 141COL Colstrip Adjustment Rider indicating that the increased rates proposed in this docket to become effective on January 1, 2025 are subject to later refund pending final determination of the matter adjudicated in this docket. The attached revised electric tariff sheets (Sheets 141COL and 141COL-A) reflect the updated language required by the Order.

In accordance with the Order, this filing is being made prior to December 23, 2024 with a proposed effective date of January 1, 2025. The issue date of this filing allows for five business days' review and response to this compliance filing, pursuant to WAC 480-07-880(4). In accordance with the Order, the tariff sheets that were included in the Company's revisions to Schedule 141COL which were filed on September 30, 2024 will also go into effect on January 1, 2025, subject to the condition that the increased rates will become effective and subject to refund as indicated in the tariff sheets included with today's compliance filing. The previously filed and now approved tariff sheets were confirmed and provided back to the Company by the Records Center on December 19, 2024.

As required by WAC 480-07-880(3), a copy of this compliance filing is being served on each party to this proceeding. The filing is being served via email.

The tariff sheets described herein reflect an issue date of December 20, 2024, and an effective date of January 1, 2025, by authority of the Washington Utilities and Transportation Commission in Docket UE-240729, Order No. 01. Proposed tariff changes will be posted on PSE's website in compliance with WAC 480-100-193. As noted above, the other tariff sheets filed on September 30, 2024 will go into effect as per Order 01.
