Recommendation

Take no action, thereby allowing tariff pages filed on December 21, 2023, and revised on March 21, 2024, to become effective April 1, 2024.

Discussion

On December 21, 2023, Bainbridge Disposal, Inc. G-143 (Bainbridge or Company), filed Tariff No. 18 with the Utilities and Transportation Commission (Commission) that would generate approximately \$1,498,000 (27 percent) additional annual revenue. Bainbridge provides regulated solid waste collection services to approximately 7,200 residential garbage and recycling, 4,000 yard waste and 450 commercial garbage customers in Kitsap County. The Company's last general rate increase became effective on February 1, 2017.

Commission staff (Staff) made some minor adjustments to payroll related to the Company's bonus program. The Company did not separate costs of garbage, recycling, or yard waste and used a single Lurito Gallagher (LG) model to determine its return. The Company provides recycling and yard waste to most of its customers, but those rates are far below the actual cost to provide those services. Commission practice has been to separate lines of business with each having its own LG model to avoid one customer group subsidizing another. However in this instance, the same customers pay for both garbage and recycling service. So to settle the case, Staff and the Company agreed to a larger increase in recycling rates and a lower increase for garbage rates to bring the rate spread more in line with the cost of service. In its next filing, the Company will separate the lines of business to better determine costs of service and appropriate rates.

Staff has completed its review of the Company's books and records and believes the Company has demonstrated the rate increase is necessary to provide service. Staff believes the revised rates agreed upon by the Company are fair, just, reasonable, and sufficient.
