Q. Please state your name and business address.

Q. By whom are you employed and in what capacity?

A. I am employed by Puget Sound Energy, Inc. ("PSE") as Director, Power & Gas Supply Operations.

Q. What are your duties as Director, Power & Gas Supply Operations?
