- a. an explanation of the corporate history of the pipeline including the dates of the ownership changes of the pipeline;
- b an explanation of all expansions of the pipeline including dates of construction, cost of the expansions, and capacity increases;
- c. dates when new origin and destination points were added, and connections with new pipelines;
- d. dates when new services were added;

e. an explanation of the dates and circumstances when any part of the pipeline or a particular line segment was not operational or not in use or taken out of service.

Please describe all non-carrier activities operated by Olympic. For each non-carrier service please list on a yearly basis the service performed and the amount of non-carrier revenue, related volumes if applicable for the years 1995 through 2001.

Please provide copies of Olympic's FERC Annual Form 6 for each year since 1983.

Staff/Olympic 6:

Please provide a complete explanation of Olympic's terminal operations and describe all services performed at the terminals.

Please provide the revenues and volumes per terminal for terminal operations for each calendar year from the 1995 though 2001, state whether the revenues and volumes are considered interstate or intrastate in nature and/or carrier or non-carrier revenues.

Please provide all studies that Olympic or its predecessors and/or affiliates have performed or contracted for related to throughput on Olympic's system.
