JUDGE CAILLE: We're here this afternoon for a prehearing conference in the proceeding captioned: In the Matter of the Petition of U S West for 5 Competitive Classification of Business Services in 31 6 Specified Wire Centers, which is Docket No. UT-000883. 7 Today is October 25th, 2000, and we are convened in a 8 hearing room at the Commission's offices in Olympia, 9 Washington.
