Avista Corporation ("the Company") hereby submits the attached filing seeking Commission authorization to increase its rates and charges for its electric and natural gas services to its electric and natural gas customers in the state of Washington. In this filing the Company requests an overall increase in billed rates of 8.8% (9.0% in base rates) or \$41.0 million for electric service. As a part of its filing, the Company is proposing an Energy Recovery Mechanism Rebate ("ERM Rebate") of 2.9%. The net effect of the general rate increase coupled with the ERM Rebate is an overall increase in billed rates of 5.9%.

In addition, the Company requests an overall increase of 6.8% in billed rates (7.0% in base rates) or \$10.1 million for natural gas service. The Company is requesting that the proposed rates be implemented at the end of the general rate case proceedings.

Additionally, Avista Corporation requests that the Commission **immediately suspend the operation of the general tariff revisions** included in this filing, and promptly set the matter for hearing, including the establishment of a prehearing conference, at the earliest possible date in accordance with WAC 480-07-440(1)(a).

193(1) and WAC 480-100-193(1), the Company will post the proposed changes to its tariffs for public inspection and review on its website, and will provide access via request by telephone or mail. A service list is attached, with the parties on the service list receiving a complete copy of the pre-filed testimony and exhibits.

In compliance with WAC 480-07-510(3)(i) the Company states that there are no additional material affiliated transactions to report that otherwise were not already reported in the Company's annual Report of Affiliated Interest Transactions for the test year. The Company's annual report was filed on April 29, 2011. (See Dockets UE-110771 and UG-110772)

Please note that the Company has simultaneously filed "Avista Corporation's Motion for a Protective Order Pursuant to RCW 34-05-445 & WAC 480-07-423".
