Amendment Number: 27

Description of amendment: This agreement is amended by adding the terms, conditions and rates relating to Collocation augments, as set forth in Attachment 1 and Exhibit A attached hereto. The parties agree that the rates in this document are for the limited purposes of this Amendment. CLEC and Qwest reserve their rights to assert different language and/or rates in other contexts.

The amendment amends the interconnection agreement approved by the Commission on December 9, 1998 in WUTC Docket No. UT-980380.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.



The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
