This filing incorporates the necessary changes to CenturyLink's WN-U2 to complete documentation of the consolidation of:

- the Hansville and Kingston exchanges (surviving exchange of Kingston).
- the Neah Bay, Clallam Bay, Beaver and Forks exchanges (surviving exchange of Forks).
- the Long Beach, Ocean Park and Chinook exchanges (surviving exchange of Long Beach).
- the Friday Harbor, Lopez, East Sound and Blakely Island exchanges (resulting exchange name of San Juan).

All other activities associated with these rate center consolidations have previously been completed and this filing merely updates the Company's tariff to reflect the previously completed rate center consolidations. This filing is being made in compliance with Condition 28(a) of the Settlement Agreement between CenturyLink, the Commission Staff and Public Counsel in the CenturyLink/Qwest merger case, Docket UT-100820.
