QWEST'S DEMONSTRATION OF COMPLIANCE WITH COMMISSION ORDERS AS OF APRIL 19, 2002

On April 3, 2002, the Washington Utilities and Transportation Commission ("Commission") entered the 29th Supplemental Order in this matter addressing the process for review of certain remaining issues. In paragraphs 7 and 8 of that order, the Commission required Qwest Corporation ("Qwest") to file a document that lists, for each ordering paragraph in the Commission's orders that required Qwest to either change its SGAT or its behavior to comply with its obligations for a checklist item, the SGAT section or other documentation that demonstrates Qwest's compliance with the orders. Attached hereto is that document.

The document is set up as a table, with three columns. As shown on the column headings, the first column identifies the requirement from either the initial or final order by paragraph number, the second column provides a brief narrative description of the requirement, and the third column identifies the SGAT section that was changed to comply with the requirement, or other evidence of compliance if changed SGAT language was not required. The only order at issue in this particular demonstration of compliance is the 31st Supplemental Order on Reconsideration. That order addressed issues raised in petitions for reconsideration in connection with both Workshop 3 and Workshop 4 final orders. (During a prehearing conference on April 18, 2002, it was determined that QPAP compliance issues would not be addressed in this filing, but rather would be addressed after the Commission issues an order on reconsideration of the QPAP issues.) Qwest has referenced the specific ordering paragraph for each requirement, not the discussion and decision paragraphs within the body of each order. This is consistent with the format required by the 29th Supplemental Order.
