Dear Mr. Mayo,

This letter serves as Cascade Natural Gas Corporation's (CNGC) notification as required per Settlement Agreement, Docket PG-150120 Section V.B.3., between the Staff of the Washington Utilities and Transportation Commission (WUTC) and CNGC.

Section V.B.3. requires CNGC to notify the WUTC when a pipeline segment returns to code-based survey intervals based from information available to substantiate SMYS below 20% or to validate the MAOP of a pipeline segment. Pipeline segment length that will be returning to leak survey intervals prescribed by code include the following:
