- The G Certificates issued by the WUTC contain a description of the geographic territory where service is authorized, and state the commodities that may be collected within each territory. Solid waste collection companies file maps with the WUTC that are supposed to accurately reflect the territory described in the certificate. In the late 1990s, the WUTC undertook an effort to update its mapping and information systems. The WUTC maps regarding solid waste collection certificates had fallen into disarray. In addition, decades of transfers of certificates and purchases of multiple certificates by a few companies resulted in some solid waste collection companies holding certificates that contained overlapping or duplicate authority or which could be described more clearly in terms of the commodities or operating area that were authorized. The WUTC sought to provide improved mapping as part of a new WUTC Geographic Information System ("GIS"). The GIS mapping effort was to provide both better mapping for accuracy in the description of those areas subject to WUTC jurisdiction, and to also provide a better source of information to companies, consumers and the public. For example, various certificates issued to solid waste collection companies had contained references to roads that no longer existed, or to descriptors that were no longer accurate. The GIS system was intended to provide for the correction of such deficiencies and descriptions, eliminate overlaps in regulated service, identify potentially improper service outside of authorized areas, and identify areas where no certificates had been issued.
- 4. The WUTC Staff worked with the solid waste collection companies to rectify and address the above issues. One result of the WUTC's efforts to bring current its mapping was that a solid waste collection company that held more than one certificate sometimes chose to consolidate its certificates into one certificate.
- 5. The consolidation of solid waste certificates was not the result of a mandatory directive issued by the WUTC to solid waste collection companies subject to WUTC

jurisdiction. The consolidation was not a planned or policy-driven effort of the WUTC to address or direct substantive matters. Rather, the GIS mapping process that led some companies to choose to consolidate was simply an administrative and record-keeping function of the WUTC. Consolidation assisted the WUTC in providing more accurate mapping of service areas under its jurisdiction.

- 6. Rabanco requested the Commission to consolidate three of its certificates. Rabanco filed an application for that purpose, and the Commission granted that application. My Staff's review of the WUTC's file in that docket found nothing that stated or suggested that as a result of consolidating its certificates into one certificate, Rabanco would claim that a county comprehensive solid waste management plan or implementing ordinance might no longer comply with state law regarding designation of a disposal site or sites.
- 7. Attached as Exhibit A to this declaration is an example of correspondence that describes the efforts of the WUTC to provide for modernization of its mapping of authorities.
- 8. In the WUTC's regulation of solid waste collection companies, "tariffs" are distinct from "certificates." Certificates state the total geographic area in which the company is allowed to operate. Tariffs set forth the rates and conditions of service the company provides. Tariffs are typically more limited than certificates in geographical scope. For example, a solid waste collection company with a large geographic area described in its certificate typically will have more than one tariff, each applying in different areas of the certificate. The WUTC uses operational characteristics and costs within a particular tariff area to evaluate, and set the rates for services provided in that tariff area.
- 9. Attached to this declaration as Exhibit B are WUTC Order Nos. 030433, 030434 and 030590, issued August 21, 2003, consolidating certificates under WUTC certificate G-12 and re-issuing Certificate G-12 ("Order"). As set forth on the face of the Order, the authority in the certificate is "contingent upon applicant having complied with the provisions of chapter

25.

- 10. I am familiar with the provisions of RCW 81.77.030(5) that requires the WUTC to supervise and regulate every solid waste collection company in the state "by requiring compliance with local solid waste management plans and related implementation ordinances." I am not aware of any formal action of the WUTC that has been required to enforce this provision of state law. Solid waste collection companies throughout the state generally participate in the county process in developing the local comprehensive solid waste management plans, implement the service levels set forth in those plans, and the WUTC's supervisory and regulatory roles have not been triggered in the past regarding a solid waste collection company's compliance or noncompliance with a local comprehensive solid waste management plan or implementing ordinances. Nonetheless, the WUTC is required by law to ensure compliance with RCW 81.77.030(5), which is consistent with the WUTC Order on Certificate G-12 requiring compliance with that Chapter as a condition of consolidation and re-issuance of the Certificate.
- 11. I have reviewed Rabanco's Certificate G-12, and it does not authorize service in Pierce County.
- 12. I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.







Dear Ms. Jennings:

In your April 30, 2004, letter you ask the following question:

If King County does not have interlocal agreements with the counties identified in Rabanco's G-12 certificate, would the WUTC nonetheless require Rabanco's compliance with the County's designation of a solid waste disposal site within King County consistent with the WUTC's authority?

For the reasons stated below, we answer your question in the affirmative.

Facts

The Commission has issued Certificate G-12 to Rabanco, Ltd. (Rabanco). The certificate permits Rabanco to collect solid waste in areas of the following counties: King, Snohomish, Yakima, Skamania, and Klickitat (including certain cities located within certain of such counties).

Pursuant to RCW 70.95, King County has adopted a Solid Waste Management Plan (Plan), which is enforced by implementing county ordinances. Under this Plan and ordinances, solid waste generated and collected in King County must be disposed of at disposal sites designated in the Plan. King County has designated disposal sites located only in King County; no other county is involved.

Discussion

The Commission is required "to supervise and regulate every solid waste collection company in this state," ... "by requiring compliance with local solid waste management plans and related implementation ordinances." RCW 81.77.030(5). Also, "[a] condition of operating a solid waste company in the unincorporated areas of a county shall be complying with the solid waste management plan prepared under chapter 70.95 RCW applicable in the company's franchise area." RCW 81.77.040.

Because the King County Plan designates disposal sites only in King County, if Rabanco were to transport solid waste generated and collected in King County to a disposal site located in another county, that would be a violation of the Plan and implementing ordinances. RCW 81.77.030(5) would then require the Commission to require Rabanco to comply by ceasing the disposal of such solid waste in a county other than King County.

The issue is whether the third sentence in RCW 36.58.040 changes this conclusion. That sentence states:

However for any solid waste collected by a private hauler under a certificate issued by the Washington utilities and transportation commission under the provisions of chapter 81.77 RCW and which certificate is for collection in a geographic area lying in more than one county, such designation of disposal sites shall be pursuant to an interlocal agreement between the involved counties.

If the Commission were to consider enforcement of King County's Plan under the facts assumed, it would need to determine whether this third sentence in RCW 36.58.040 applies. For the reasons stated below, it does not apply.

First, as the facts assume, the King County Plan requires solid waste that is collected in King County to be disposed of in King County. No other county is involved or otherwise affected by that activity. Consequently, the third sentence of RCW 36.58.040 does not apply because there is no "involved county" for purposes of that sentence, other than King County.

In addition, under the Interlocal Cooperation Act, RCW 39.34, interlocal agreements apply only to "joint and cooperative action" between units of government. RCW 39.34.030(2). In this instance, King County has no opportunity for "joint and cooperative action" because all the relevant activities take place solely in King County; no other county is affected. Consequently, the third sentence of RCW 36.58.040 does not apply because the sort of interlocal agreement described in that sentence is not available under the assumed facts.

Moreover, requiring an interlocal agreement under the assumed facts makes no sense. Many of the solid waste collection company certificates the Commission has issued authorize solid waste collection in multiple counties. The Rabanco certificate is one of them. It is nonsensical that the Legislature would require King County to have an interlocal agreement with Snohomish, Pierce, Yakima, Skamania, and Klickitat Counties before King County could designate a disposal site in King County for disposal of solid waste generated and collected in King County alone.

Consider also the situation where a solid waste collection company has a certificate authorizing it to collect solid waste only in King County, and is therefore required by King County's Plan to dispose of that solid waste at designated disposal sites in King County. Assume the company later applies to the Commission for authority to operate in, say, Clark County, and the Commission grants that application, amending the company's certificate to add Clark County. It makes no sense to interpret RCW 36.58.040 to require King County to have an interlocal agreement with Clark County, since Clark County is completely unaffected by such designation, collection and disposal, when the only change in circumstances is the amendment of the certificate.

Our conclusion is consistent with the apparent purpose of RCW 36.58.040. An interlocal agreement makes sense when one county designates a solid waste disposal site in a different county, and a solid waste collection company has authority to collect solid waste in both counties. In that scenario, both counties are "involved counties" for purposes of the third sentence of RCW 36.58.040. The involved counties are expected to agree between them (via an interlocal agreement) how the solid waste affecting both counties should be dealt with. This assures that the certificated hauler can follow a county designation of disposal sites with confidence it will be in compliance with each county's requirements. That is simply not an issue when the solid waste is collected and disposed of in a single county.

The foregoing analysis is consistent with the legislative history of RCW 36.58.040 that we were able to locate. The language at issue was first enacted in 1975, by way of Second Substitute House Bill 721, § 2. The Bill Digest for that bill states in part that the bill "[r]equires designation of sites for collections by state licensed private haulers from multi-county areas to be made under an interlocal agreement between the counties." (emphasis supplied). This confirms our opinion that the statute addresses the situation when solid waste hauled by a certificated solid waste collection company to a disposal site comes from more than one county. In that context, the designation of the disposal site must be made by an interlocal agreement between the involved counties.

Conclusions

In sum, under the facts contained in your April 30, 2004, letter, under RCW 81.77.030(5), the Commission would likely enforce the provisions of King County's Plan and implementing ordinances and require Rabanco to dispose of solid waste collected in King County at a disposal site designated by King County in its Plan. Any enforcement action the Commission might take would be governed by applicable statutory and administrative requirements, and the Commission's decision would be subject to judicial review. We also note that King County can enforce its own ordinance through administrative or judicial procedures. As a practical matter, King County's enforcement actions would likely reach a final resolution much sooner than the Commission's administrative processes.

We hope the foregoing will provide you the guidance you desire. Please understand the foregoing is the opinion of the Commission's Staff, and is not necessarily that of the Commission should it be called upon to decide this issue in a formal proceeding.
