BACKGROUND

- 1 On July 14, 2004, Rainier View Water Company, Inc., (Rainier View or Company) filed with the Commission revisions to its currently effective Tariff WN U-2, designated as Original Sheet No. 49.
- 2 On August 25, 2004, the Commission entered a Complaint and Order Suspending Tariff Revisions pending an investigation to determine whether the revisions are fair, just and reasonable.
- 3 The Company has filed a substitute tariff and the changes in the substitute tariff satisfactorily address the concerns of the Commission and Staff expressed in the August 25, 2004, Open Meeting.

FINDINGS AND CONCLUSIONS

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate rates, rules, regulations, practices, accounts, securities, and transfers of

public service companies, including water companies. *RCW 80.01.040; Chapter 80.04 RCW and Chapter 80.28 RCW.*

- 5 (2) Rainier View is a water company and is a public service company subject to the jurisdiction of the Commission.
- 6 (3) This matter was brought before the Commission at its regularly scheduled meeting on September 8, 2004.
- 7 (4) The tariff revision presently under suspension is fair, just and reasonable.
- 8 (5) After review of the tariff revision(s) filed in Docket UW-041270 by Rainier View and giving due consideration, the Commission finds it is consistent with the public interest that the Complaint and Order Suspending Tariff Revision in Docket UW-041270, dated August 25, 2004, be dismissed and the tariff revision(s) to Tariff WN U-2 become effective on September 9, 2004.

ORDER

THE COMMISSION ORDERS:

- 9 (1) The Complaint and Order Suspending Tariff Revision(s) in Docket UW-041270, dated August 25, 2004, is dismissed.
- 10 (2) The tariff revisions filed in this docket on July 14, 2004, shall become effective on September 9, 2004.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
