This letter is to inform you of the status of the Commission's rulemaking to expand customer payment options, and allow solid waste/refuse companies to issue electronic billing to customers on request, by amending WAC 480-70-401 (Payment option), and WAC 480-70-396 (Billing). This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing.

On September 22, 2004, the Commission filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
