Discussion

On July 13, 2005, Evergreen Moving & Storage, LLC, filed Application No. P-79388 requesting permanent household goods authority.

The commission granted Evergreen Moving & Storage, LLC, temporary authority on July 21, 2005, subject to conditions pending a decision on its application for permanent authority. The commission sent a letter to Yaron Hadad on August 5, 2005, requesting him to change the company name due to another company having a similar name, Evergreen Moving Systems, Inc. (HG1973). WAC 480-15-390 states that you may not operate under a name that is similar to that of another carrier without that carrier's written permission or UTC approval. On December 27, 2005, the commission received a written request from Yaron Hadad to revise the application name to Y.M.1 Any Time Moving, LLC. An order was issued on March 17, 2006 revising application name and reissuing temporary authority pending a decision on permanent authority. The company has operated under Household Goods Carrier Permit No. HG-61911 since July 21, 2005.

Application No. P-7938 appeared on the commission's August 1, 2005, application docket subject to comment for no less than 180 days while the company conducted operations under its temporary authority. No comments were received.

Under the provisions of WAC 480-15-330 the commission will grant or deny an application for permanent authority after conducting a complete review of the

application filing, supporting statements, reports, or other information necessary to determine fitness, public interest, and current or future public convenience and necessity.

Yaron Hadad is 100% member of Y.M.1 Any Time Moving, LLC. He states that he has not been convicted of a Class A or B felony or previously been denied authority based on fitness.

Compliance staff worked with the company providing technical assistance during its temporary operations. Investigator Tom McVaugh completed an economic and safety review of the company's operations and found the company in general compliance. On October 20, 2006, Investigator McVaugh recommended the applicant be considered for permanent authority.

Y.M.1 Any Time Moving, LLC, is registered with the Secretary of State and holds a valid UBI number.

During the company's temporary operations the commission received no customer complaints regarding this company's service.

Recommendation

P-79388 is an uncontested application and therefore no hearing is required. There are no outstanding issues that suggest staff should ask the commission to set the application for hearing.

I recommend that Licensing Services Staff prepare an order to grant Application No. P-79388 without hearing and reissue Permit No. HG-61911 to Y.M.1 Any Time Moving, LLC, as unrestricted permanent authority to operate as a household goods carrier in the state of Washington.
