BETWEEN: Pasco, WA and Walla Walla, WA; from Pasco to North on 7th Avenue to West Brown Street, over West Brown Street onto West Court Street, over West Court Street onto North 4th Avenue, over North 4th Avenue to US HWY 12 East, over US HWY 12 to US HWY 395 to Spokane, WA, over US HWY 395 to Spokane to 2nd Avenue to city center, over north 2nd Avenue to West Alder Street, over west Alder Street to Walla Walla, WA, and return over the same route; serving all intermediate points.

NOTE: Intrastate authority is granted consistent with the federal grant of authority under MC-315161 and limited to intrastate operations that are conducted together with regularly scheduled interstate operation on the same route

The commission should issue the requested certificate to provide intrastate regular route service under the provisions of 49 U.S.C.§13902. The intrastate operations are conducted together with regularly scheduled interstate operations over the route authorized by the Federal Motor Carrier Safety Administration in MC-315161.

ORDER

IT IS ORDERED That Application D-79427 of Genie Service Company, Inc., d/b/a Genie Tour Coaches, is hereby granted, conditioned upon compliance with the laws and rules governing passenger transportation services, and that Certificate C-1033 is amended to read as follows:

Service authorized by this certificate which may be within the boundaries of a public transportation authority may only be conducted under agreement with the affected Public Transportation Benefit Area, Municipal Transit Authority, or Regional Transit Authority as required by law.
