Fuel index prices have increased from \$2.9424 per gallon for the base period to \$4.5023 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 13 in the amount of 1.39%.

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August 2008 and September 2008.
