The company requests Commission approval to amend its filed Tariff Number 15 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$1.927 per gallon for the base period (12 months ended December 31, 2004) to \$4.44 per gallon current price.

Proposed changes are to add a Special Fuel Surcharge in the amount of: 3.54%


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August, September and October 2008.
