
1. The Commission finds good cause to support the request and authorizes the proposed changes to become effective with Less Than Statutory Notice on: August 1, 2008.
2. The proposed changes will expire on: December 31, 2008.
3. The temporary 3.25% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April, May and June 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August, September and October 2008.

Customers who are billed quarterly for services – current month and two months in advance:

Customers Billed in the Month of:	Fuel Surcharge applies to all services provided in the months of:
August 2008	August, September and October 2008
September 2008	September, October and November 2008
October 2008	October, November and December 2008
