RE: Washington Utilities and Transportation Commission v. Sino-M International, LLC d/b/a Seattle May Travel Commission Staff's Recommendation to Waive Suspended Penalties Docket TE-160911

Dear Mr. Johnson:

In Order 01 of Docket TE-160911, Sino-M International, LLC d/b/a Seattle May Travel (Seattle May Travel or Company) was assessed a penalty of \$6,900. The penalty was the result of an investigation conducted in May 2016 in which staff discovered 83 violations of WAC 480-30-221, which adopts by reference Title 49 of the Code of Federal Regulations (49 CFR) Part 391 related to driver qualifications, and Part 396, related to vehicle inspection, repair and maintenance.¹

Seattle May Travel requested mitigation of the assessed penalty and the Commission suspended a \$3,000 portion of the penalty for a period of two years, and then waived, subject to the following conditions: 1) The Company must maintain a "conditional" safety rating, 2) Seattle May Travel may not incur any repeat violations of WAC 480-30-221, and 3) the Company must pay the \$3,900 portion of the penalty that is not suspended.

On September 13, 2016, the Commission's Financial Services department filed a statement of account in this docket noting that the \$3,900 unsuspended portion of the penalty was paid in full.

In accordance with Docket TE-160911, staff completed the required follow-up safety investigation in July 2018. Staff did not discover any repeat violations during this investigation.

Staff finds that Seattle May Travel has maintained a "conditional" safety rating and the conditions of Order 1 have been satisfied.

Staff recommends the \$3,000 suspended penalty issued against Seattle May Travel be waived and the docket closed.
