Status of Compliance of Companies Named in Notice of Intent to Revoke Registration

Dear Mr. Johnson:

On October 2 and October 12, 2018, the Commission served a Notice of Intent to Revoke Competitively Classified Telecommunications Company Registration and Opportunity to Request a Hearing (Notice) on one or more competitively classified telecommunications companies. The Notice stated that the Commission would revoke each company's registration unless, within 30 days, the company (1) came into compliance with applicable law by submitting the delinquent annual report and paying the required regulatory fee or (2) requested a hearing to demonstrate why the company's registration should not be revoked.

More than thirty days have now elapsed since the last company was served with the Notice. As of December 19, 2018, 15 companies have come into compliance. Because these companies are now in compliance, the Commission need not revoke their registrations. Additionally, one company has ceased operations. The remaining 15 companies still have not filed a 2017 annual report and/or paid 2018 regulatory fees.

Attached is a table showing the compliance status of all of the companies that received the Notice. Staff recommends that the Commission revoke the registrations of those 15 companies that remain out of compliance with the Commission's annual report and regulatory fee submission rules.
