RE: *Washington Utilities and Transportation Commission v. Friday Harbor Jolly Trolley, Inc., d/b/a Friday Harbor Jolly Trolley; Leavenworth Jolly Trolley; Roche Harbor Express*
Commission Staff's Recommendation to Waive Suspended Penalties
Dockets TE-191003 and TE-191002 (*Consolidated*)

Dear Ms. Maxwell:

On January 9, 2020, the Washington Utilities and Transportation Commission (Commission) entered Order 01, Consolidating Dockets; Approving Safety Management Plan; Upgrading Safety Rating; Imposing and Suspending Penalties in Dockets TE-191003 and TE-191002. Order 01 granted Friday Harbor Jolly Trolley, Inc., d/b/a Friday Harbor Jolly Trolley; Leavenworth Jolly Trolley; Roche Harbor Express' (Jolly Trolley or Company), request for mitigation, assessed a penalty of \$3,200, and suspended a \$2,000 portion of the reduced penalty for a period of two years, and then waived, subject to the following conditions:

- (1) Jolly Trolley maintains a conditional safety rating;
- (2) Commission staff (Staff) conducts a follow-up investigation at least six months from the date of the order;
- (3) Jolly Trolley must not incur any repeat critical violations of WAC 480-30-221 upon re-inspection; and
- (4) Jolly Trolley pays the \$1,200 penalty or works with Staff to establish a mutually agreeable payment arrangement.

On January 16, 2020, the Company paid the penalty in full.

On November 16, 2021, Staff completed the required follow-up safety investigation as outlined in Order 01. Jolly Trolley did not receive any repeat critical violations of WAC 480-30-221 and received a satisfactory safety rating.

Staff finds that Jolly Trolley satisfied the conditions of Order 01 and recommends that the \$2,000 suspended penalty be waived.
