## RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE

Dear Customer:

May 1, 2020

Island Disposal Company, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC July 2, 2012. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates below will become effective June 1, 2020.

The Commission has the authority to set final rates that may be either lower or higher from the company's request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 9:30 a.m. on May 21, 2020. The UTC building is closed to the public until further notice.
