## Re: Docket UE-240405—2024 Annual Renewable Portfolio Standard Report - Revised

PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp) submitted its 2024 Annual Renewable Portfolio Standard Report to the Washington Utilities and Transportation Commission on May 30, 2024.

In a review with Washington Utilities and Transportation Commission staff, it was discovered that the company inadvertently reported the retail sales for average retail sales in the original report. PacifiCorp also had a few typographical errors in the narrative and in Attachment C. Finally, Commission staff requested additional clarification on the revenue requirement calculation. All modifications are detailed below:
