PACIFIC POWER & LIGHT COMPANY'S MOTION TO AMEND THE PROCEDURAL SCHEDULE

Pacific Power & Light Company (Pacific Power), a division of PacifiCorp, moves for the entry of an order amending the Procedural Schedule by the Washington Utilities and Transportation Commission (Commission) as follows.

On October 26, 2017, after a prehearing conference with all parties, the Commission issued its Procedural Schedule. On November 8, 2017, Pacific Power filed a motion to amend the procedural schedule. On December 22, 2017, a revised procedural schedule was issued by the Commission laying out the following dates:

Under Wash. Admin. Code §480-07-385, a continuance may be granted by the Commission if the requesting party demonstrates good cause and that no other party or the Commission will be prejudiced. Upon reviewing testimony, Pacific Power realized that certain information responsive to discovery from Commission Staff (Staff) had been omitted. Pacific Power notified Staff on Monday, March 5, 2018, and supplemented the discovery response the next day, Tuesday, March 6, 2018. After discussions with the parties and in order to provide the parties an opportunity to respond to this new information, Pacific Power requests that all parties be allowed to file Supplemental Testimony and Exhibits.

Pacific Power requests that the Commission issue an order limiting the scope of supplemental testimony solely to the non-duplicative¹ supplemental data responses that were produced on Tuesday, March 6, 2018. This is necessary in order to ensure that the hearing date, which has already been delayed once, need not be delayed again. Pacific Power has discussed this provision with Staff, Boise White Paper, LLC. (Boise), and Public Counsel. None of the parties object to this limitation. Therefore, good cause exists to adjust the procedural schedule in order to ensure that no Parties have been prejudiced.
