On April 6, 2022, the Washington Utilities and Transportation Commission (Commission) issued a Complaint and Notice of Prehearing Conference (Complaint) concerning CenturyLink Communications, LLC d/b/a Lumen Technologies Group, Qwest Corporation, CenturyTel of Washington, Inc., CenturyTel of Inter Island, Inc., CenturyTel of Cowiche, Inc., and United Telephone Company of the Northwest (collectively Lumen or Company). The Complaint alleges violations of WAC 480-120-172(3)(a) governing involuntary discontinuance of telecommunications service.

On May 24, 2022, the Commission entered Order 01, Prehearing Conference Order, adopting a procedural schedule and setting an evidentiary hearing in this matter for March 24, 2023, at 9:30 a.m.

On March 13, 2023, the Commission issued a Notice Canceling Evidentiary Hearing and Notice of Deadline for Objections to Cross-Examination Exhibits (Notice). The Notice canceled the evidentiary hearing and determined that the Commission would decide this matter on a paper record. The Notice also required parties to file any objections to cross-examination exhibits by March 24, 2023.

The Commission received no objections to any of the proffered exhibits and thus finds good cause to admit into the evidentiary record all exhibits and cross-examination exhibits filed by the
