## **Extension of Time to File Petitions for Interlocutory Review**

- The Fifth Supplemental Order served on April 11, 2002, denied Qwest Corporation's ("Qwest") motion to suspend proceedings. However, Qwest was allowed the opportunity to submit additional arguments and evidence to establish that the Commission intends to make a determination whether IMA GUI provides access to Qwest's OSS in substantially the same manner as SONAR or IMA EDI in the SGAT/271 Proceeding. The Sixth Supplemental Order served on April 18, 2002, denied Qwest the opportunity to file additional supplemental comments prior to petitioning for interlocutory review pursuant to WAC 480-09-760. The Sixth Supplemental Order also tolled the time for the parties to file a petition for review of all decisions until after an order was entered regarding the additional arguments filed by the parties. Qwest filed additional arguments and evidence on April 22, 2002. Tel West Communications, LLP ("Tel West") filed a response on May 2, 2002.
- On May 10, 2002, the Commission served to the parties a Notice of Expedited Interlocutory Review and Opportunity to File Petitions and Answers. The Notice stated that the Commission will accept interlocutory review based on the orders to date and the parties' submissions regarding provisioning parity issues. Petitions for review and answers were scheduled to be filed on May 17 and May 22, 2002, respectively.
- The parties on May 15, 2002, jointly requested an extension of time to file petitions in order to provide an opportunity for Qwest to present and Tel West to respond to a settlement proposal. Good cause exists to extend the date for parties to file petitions and answers. The date for filing petitions for interlocutory review is extended from

May 17, 2002, to **Friday, May 31, 2002**, and the date for filing answers to petitions is extended from May 22, 2002, to **Wednesday, June 5, 2002**.

#### **Procedural Schedule**

The parties have also agreed to a revised procedural schedule regarding provisioning parity issues in order to pursue settlement negotiations.
