**AT&T'S MOTION TO WITHDRAW FROM THE PROCEEDING
WITH PREJUDICE**

AT&T Communications of the Pacific Northwest, Inc. and TCG Seattle (collectively "AT&T") hereby submit this Motion to Withdraw from the above-captioned proceeding. As grounds therefore, AT&T states as follows:

1. AT&T and Verizon have been in negotiations to enter into a commercial agreement replacing the UNE-P product AT&T has previously purchased under its interconnection agreement with Verizon.

2. On September 1, 2005 AT&T and Verizon entered into an agreement that resulted from their negotiations. This agreement, while not specifically a settlement of this proceeding, makes it moot as between Verizon and AT&T.

3. Consequently, AT&T hereby requests that the Commission grant AT&T's request to withdraw from this proceeding with prejudice.

WHEREFORE, for the reasons stated above, AT&T respectfully requests that the Commission allow AT&T to withdraw from this matter.
