MEMORANDUM

1 On November 27, 2002, the Commission entered its Eighth Supplemental Order (“Order”) in this proceeding. The Order, among other things, approved certain proposed revisions to PacifiCorp’s tariff. The approved revisions are referred to in the Order as the “Modified Tariff Proposal” and are set forth, in full, in Appendix A to the Order.

2 On December 13, 2002, PacifiCorp filed revisions to its currently effective Tariff WN U-74, designated as First Revision of Sheet F-3, to comply with the Commission’s Order. On December 20, 2002, PacifiCorp filed substitute pages. After consulting with Staff, PacifiCorp filed corrected substitute pages on December 23, 2002. PacifiCorp requests that the revised tariff sheet be made effective on January 1, 2003. PacifiCorp proposes to notify customers by posting appropriate notices in its billing offices.

3 Commission Staff have reviewed the Company’s compliance tariff filings and state that the December 13, 2002 filing, as modified by PacifiCorp’s December 23, 2002 filing, appear to comply in all respects with the Commission’s Eighth Supplemental Order. The Commission finds that PacifiCorp’s proposed tariff revisions comply with the Eighth Supplemental Order in Docket UE-001734 and concludes that the tariff revisions should be approved and become effective as filed.

ORDER

4 THE COMMISSION ORDERS That the tariff revisions filed by PacifiCorp on December 13, 2002, as modified by the substitute tariff page filed on December 23, 2002, are in compliance with the Eighth Supplemental Order in this proceeding, and shall become effective as filed. The rates, charges, terms, and conditions set forth in the tariff revisions are specified as the rates, charges, terms, and conditions that will apply to service on and after January 1, 2003.

5 THE COMMISSION ORDERS FURTHER That it retains jurisdiction to effectuate the provisions of this and prior Orders entered in this proceeding.
