The attached documents are agreed by the parties to be the Exhibit A's to Qwest's SGAT during the time period specified in this Bench Request. The "8th Revised 7th Amended" was approved by the Commission on May 26, 2004 in Docket No UT-043026, while the "8th Revised 8th Amended" was approved on August 11, 2004 in Docket No. UT-043058.
