#### TO INTERESTED PERSONS:

On January 3, 2001, the Commission directed the Secretary to file a Notice of Proposed Rulemaking (CR-102) with the office of the Code Reviser in Docket U-991301, addressing the placement of rules but proposing no change in language. The CR-102 proposes moving rules requiring customer notice from the tariff rule (480-80-120 WAC) to the industry-specific rules (480-90-193 Gas Operations, 480-100-193 Electric Operations, and 480-120-043 Telecommunications Operations).

Opportunity for written comment on the <u>location</u> of the customer notice rule was provided for following the filing of the CR-102. Today's notice requests comment on the <u>content</u> of the rules and offers further opportunity for written comments on the location of the rules. Written comments should be submitted by **February 20, 2001**.

In addition to the opportunity to submit written comments, you are invited to attend a stakeholder workshop on **February 28, 2001**. At this workshop, Staff will solicit comments from stakeholders on the content of the customer notice rules along with comments on the placement of the customer notice rule.
