RE: Docket UE-200420—PacifiCorp’s 2023 Integrated Resource Plan

PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or Company) submits for filing its 2023 Integrated Resource Plan (2023 IRP) with the Washington Utilities and Transportation Commission (Commission). PacifiCorp is submitting its 2023 IRP in compliance with Order 02 in UE-200420 and WAC 480-100-625(4), which requires a two-year progress report of the previously filed plan, the Company’s 2021 IRP.¹ The 2023 IRP contains information outlining how PacifiCorp has addressed applicable procedural and substantive elements of the Commission’s rules and orders (*see* Appendix B-IRP Regulatory Compliance). The 2023 IRP is also available electronically on PacifiCorp’s website at: www.pacificorp.com/energy/integrated-resource-plan.html.

Consistent with the Company’s previous IRP filings, PacifiCorp will also be submitting electronic files to that will provide supporting information for the analyses included in the 2023 IRP. The Company has restructured its workpapers, contained within the data disks, that support the 2023 IRP in a manner that enables the public to access more information. The Company will make the non-confidential workpapers available, via USB drive, within two weeks of submitting the 2023 IRP, while the confidential versions will be provided no later than May 1, 2023. Confidential materials will be provided on a separate USB under WAC 480-07-160. These confidential materials are spreadsheets and data files containing confidential information as defined in WAC 480-07-160(2)(b), RCW 80.04.095, and RCW 81.77.210.² Specifically, the files contain competitively sensitive and proprietary information including contract pricing, detailed load forecasts, and detailed resource cost data and third-party proprietary modeling information. Disclosure of the information in these files would result in an unfair competitive disadvantage and result in financial harm to the Company. This financial harm will result from the Company’s inability to negotiate lowest-cost pricing on behalf of its customers if its contractual counterparties are put on notice that pricing and contract terms will be disclosed on

the public record. This financial harm would ultimately harm ratepayers if PacifiCorp is required to incur greater costs associated with providing electric service.

PacifiCorp plans to supplement its filing with results of its 2023 IRP sensitivity studies no later than May 1, 2023. A post-IRP filing public-input meeting has been scheduled April 13, 2023, to provide an opportunity for stakeholder discussion on the organization of the workpapers in the electronic files and results of the sensitivity studies.
