Amendment Number: 6

Description of amendment: Provides 2-wire HDSL-compatible loops.

The amendment amends the interconnection agreement first accepted by the Commission on 4/26/2000 in WUTC Docket No. UT-003031. That agreement was originally approved by the Commission on 5/26/1999 in WUTC Docket No. UT-990341 between Company A and Company C, Covad Communications Company.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
