3 This amendment would create six certificates of convenience and necessity for Rabanco,  
4 Ltd. in the currently authorized territory in each of King, Snohomish, Klickitat, Skamania,  
5 Yakima, and Kitsap Counties (as well as Pierce County, if Rabanco has operating authority in  
6 Pierce County) included in Certificate G-12 (August 22, 2003). This petition is based upon the  
7 attached declaration of Justin D. Haag and the attached memorandum of law.
