- **WAC 480-62-300 Annual reports** <u>– Regulatory fees</u>. (1) The surface transportation board annual report form R1 must be used by Class I railroad companies as the annual report form for submission to the commission. Class II and Class III railroad companies must use report forms periodically published by the commission.
- (2) Each year every railroad company is responsible for obtaining the proper report form from the commission. Reports must be completed for the preceding calendar year's operations. One copy of the completed annual report, along with the regulatory fee, must be submitted to the commission no later than May 1 of the succeeding year.
- (3) **Regulatory Fees.** The railroad company regulatory fee is set by statute at one and one half percent of gross intrastate operating revenue.
 - (a) The maximum regulatory fee is assessed each year, unless the commission issues an order establishing the regulatory fee at an amount less than the statutory maximum.
 - (b) The minimum regulatory fee that a railroad company must pay is \$20.
 - (c) The \$20 minimum regulatory fee is waived for any railroad company that reports less than \$1,300 in gross intrastate operating revenue.
