- 1 NATURE OF PROCEEDING. Docket No. UW-042132 is a complaint proceeding that concerns a Roche Harbor Water System (Roche Harbor) proposed tariff revision establishing an Improvement Charge to new customers depending on the size of the customer's meter.
- CONFERENCE. The Washington Utilities and Transportation Commission (Commission) convened a prehearing conference in this docket at Olympia, Washington on May 2, 2005, before Administrative Law Judge Theodora M. Mace.
- APPEARANCES. Richard A. Finnigan, attorney, Olympia, WA, represents
 Roche Harbor, the respondent. Lisa Watson, Assistant Attorney General,
 Olympia, WA, represents the Commission's regulatory staff ("Commission Staff" or "Staff").¹

¹ In formal proceedings, such as this case, the Commission's regulatory staff functions as an independent party with the same rights, privileges, and responsibilities as any other party to the proceeding. There is an *"ex parte* wall" separating the Commissioners, the presiding

- 4 **PETITIONS FOR INTERVENTION.** No party appeared at the conference seeking to intervene.
- 5 **PROTECTIVE ORDER.** A protective order will be entered in this docket.
- 6 **DISCOVERY.** The parties asked that the discovery rules be invoked in this docket, pursuant to WAC 480-07-400. The matter is one that qualifies for discovery, and the rules are invoked.
- IOCATION OF HEARING. Roche Harbor requests that the Commission convene the hearings in the San Juan Islands, where Roche Harbor and its customers are located. Roche Harbor states that it will present one or two witnesses in the evidentiary phase of the case, but that many Roche Harbor customers support the proposed tariff change and want to attend both the evidentiary hearing and the public hearing. Roche Harbor states that even though the tariff change sought does not directly affect current customers, unless they own lots being held for future development, the proposed tariff will have an affect on the community as a whole. Roche Harbor argues that this broader community interest, and the public interest in a fair and open regulatory process, is best served by holding the hearings in the San Juan Islands.
- 8 Commission Staff opposes the request to hold hearings in the San Juan Islands. Staff objects that it is more costly for the state to hold hearings in the islands generally, but that it would be especially costly during the height of the summer tourist season when the hearings are scheduled to take place.

Administrative Law Judge, and the Commissioners' policy and accounting advisors from all parties, including Staff. *RCW* 34.05.455.

- 9 The Commission seeks to balance the interests of both parties, and the public interest, in determining the best location for a hearing. An important consideration in where to hold a hearing is the number of witnesses to be called and the distance they must travel to the hearing site. Another important consideration is the cost in time, personnel and expense to the state when a hearing is held at a site other than Olympia.
- In this case, Roche Harbor will present two witnesses at most in the evidentiary hearing. Staff proposes two or three witnesses. In light of the small number of witnesses attending the evidentiary hearing, and the expense of bringing an administrative law judge, a reporter, Staff counsel and Staff witnesses to an offsite hearing location, it is concluded that it would best serve the public interest to schedule the evidentiary hearing in Olympia, Washington.
- For the public hearing, it appears that a potentially large number of customers may wish to attend and speak about the tariff change. Therefore, the Commission will hold the public hearing in Burlington, Washington, which is near the Anacortes ferry dock for ferries from the San Juans. This will permit Roche Harbor customers an opportunity to attend at a location closer to home. The parties should confer on an appropriate date and time for the public hearing and advise the Commission by May 27, 2005 of their recommendations.

- 13 DOCUMENT PREPARATION AND FILING REQUIREMENTS. Parties must file with the Commission an original plus seven (7) copies of all pleadings, motions, briefs, and other prefiled materials. Absent such objection, this Order will control further proceedings in this matter, subject to Commission review.
