1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: August 1, 2008.

3. The temporary 4.01% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April, May & June 2008, to be collected from customers as follows:


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of August, September & October 2008.
