Dear Judge Moss:

In an Order entered on consolidated Docket No. TR-100572 and dated October 5, 2010, ("Order") the Commission "instructed the parties to file their requests for severance and withdrawal of the petitions in Dockets TR-100573 - TR-100576, indicating that these would be favorably received by the Commission." Order, p.2. During the September 27, 2010, prehearing conference the Commission stated that a letter motion would be sufficient for this purpose.

Pursuant to the Commission's instructions, WAC 480-07-320, and WAC 480-07-380(3), Benton County now requests that TR-100573, TR-100574, TR-100575, and TR-100576 be severed from the consolidated proceedings and that the County be permitted to withdraw those petitions. If the County's request is granted, it will leave TR-100572 as the sole matter remaining before the Commission.

As discussed at the September 27, 2010, prehearing conference, Benton County intends to later refile petitions identical to TR-100573 and TR-100576 as new matters.
